
AND

(First Party and Second Party are hereinafter jointly referred to as Parties, and individually as 'Party')

WHEREAS:

- First Party is a Higher Educational Institution named, Kharupetia College, established in the year 1981 in Darrang District.
- Joint Directorate of Health Services, the Second Party has an important role in the provision and administration of health services and in order to

raise the quality, extend accountability and deliver the services fairly, effectively and courteously.

- C) This Memorandum of Understanding (MoU) is entered both the parties, with the aim of fostering collaboration and cooperation for the development of the local community and the improvement of civic amenities.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest.

#### OBJECTIVES OF THE MoU:

The primary objectives of this MoU are:

- a. To facilitate mutual cooperation between First Party and Second Party for the benefit of the local community in respect of various health related issues.
- b. To undertake joint initiatives for the improvement of health services in Kharupetia and nearby area.
- c. To promote community engagement and social responsibility among students, faculty, and staff of First Party.
- d. To support initiatives for the promotion of health and well-being in the community.
- e. To collaborate on projects aimed at community health

## **AREAS OF COLLABORATION:**

Both Parties agree to collaborate in the following areas:

1. Collaborative Research: Both parties agree to collaborate on research projects relevant to public health, healthcare management, and allied fields. This collaboration may include joint research proposals, data sharing, and publication of research findings. Research and surveys for the identification of local issues and solutions will be undergone by both the parties.
2. Training and Capacity Building: Both parties will collaborate on training and capacity building programmes such as workshops, awareness programmes, and short-term courses on topics related to healthcare delivery and management.
3. Internship and Practical Training: The Joint Directorate of Health Services will facilitate internship opportunities for students of Kharupetia College within its facilities. This will provide students with practical exposure to various aspects of healthcare delivery and administration.
4. Community Health Initiatives: Both parties will work together to organize and implement community health initiatives aimed at promoting health awareness, disease prevention, and healthcare accessibility within the region served by the Joint Directorate of Health Services.
5. Exchange of Resources: Both the parties agree to exchange relevant educational materials, publications, and resources to support academic and professional development activities.

## **DURATION:**

This MoU shall come into effect on the date of signature by both parties and shall remain in force for a period of 3 years. It may be extended by mutual consent in writing.

## **GOVERNANCE:**

A Joint Committee comprising representatives from both First Party and Second Party shall be constituted to oversee the implementation of this MoU. The Committee shall meet regularly to review progress and plan future activities.

## **TERMINATION:**

Either party may terminate this MoU by serving the notice in writing upon the other party. Termination shall not affect ongoing projects and activities already initiated under this MoU.

## **AMENDMENTS:**

Any amendments to this MoU shall be made in writing and duly signed by authorized representatives of both parties.
