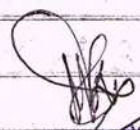

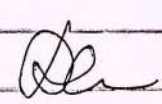

RAGGING IS A CRIMINAL OFFENCE UNDER THE LAW PUNISHABLE WITH IMPRISONMENT

As per Hon'ble Supreme Court of India's Order

Ragging is illegal and is completely prohibited and banned both inside and outside the college campus.

RAGGING is

any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any junior student, indulging in rowdy or in disciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the student(s) to do any act or perform something which the student will not do in an ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student."

PUNISHMENT FOR RAGGING :

- Suspension from attending classes and academic privileges.
- Withholding /Withdrawing scholarship/fellowship and other benefits.
- Debarring from appearing in any test/examination or other evaluation process.
- Withholding results.
- Debarring from representing the Institution in any regional, national or international meet, tournament, youth festival, etc.
- Suspension/expulsion from the hostel.
- Cancellation of admission.
- Rustication from the Institution for period ranging from 1 to 4 semesters.
- Expulsion from the institution and consequent debarring from admission to any other institution for a specific period.
- Fine of Rs. 25,000/- and Rs. 1,00,000/-.
- Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall be liable to collective punishment.
